## RESOLUTION TO AMEND 2018 BUDGET

**COMES NOW**, Jeni Reilly, the President of the Lincoln Park Metropolitan District (the "District"), and certifies that at a special meeting of the Board of Directors of the District held, Wednesday, the 5<sup>th</sup> day of December, 2018, at 6:00 P.M., at The Perfect Landing, 7625 S. WHEREAS, due and proper notice was published on November 22, 2018 in the Douglas County News Press, indicating (i) the date and time of the hearing at which the adoption of the proposed 2018 budget amendment will be considered; (ii) that the proposed budget amendment is available for inspection by the public at a designated place; and (iii) that any interested persons may file any objections to the proposed budget amendment at any time prior to the final adoption of the budget by the District, as shown on the publisher's Affidavit of Publication attached hereto as Exhibit A and incorporated herein by this reference; and

WHEREAS, the proposed budget amendment was open for inspection by the public at a designated place; and

WHEREAS, a public hearing was held on Wednesday, December 5, 2018 and interested persons were given the opportunity to file or register any objections to said proposed budget amendment and any such objections were considered by the Board of Directors; and

**NOW THEREFORE, BE IT RESOLVED** that the Board of Directors of the District shall and hereby does amend the budget for the fiscal year 2018 as follows:

\$ 36,700,000

**BE IT FURTHER RESOLVED**, that such sums are hereby appropriated from the revenues of the District to the Debt Service Fund for the purpose stated, and that any ending fund balances shall be reserved for purposes of Article X, Section 20 of the Colorado Constitution.
